# MAINTENANCE AND CONSTRUCTION CLASS

## MECHANIC

### Examples of Duties:

Under general supervision of the Mechanic Supervisor, responsible for work of average difficulty in the repair and maintenance of heavy construction equipment; performs any related work as required; repairs and maintains both gasoline and diesel-powered equipment including, but not limited to: front-end loaders, bulldozers, motorgraders, trucks, automobiles, spraying equipment, mowers and chain saws. Tunes and adjusts carburetors, ignition systems, starters and transmission; repairs electrical systems, wiring, lights and accessories; rebuilds starters, generators and carburetors; lubricates equipment; changes oil and filters; performs both arc and acetylene welding; repairs flat tires; and operates heavy equipment, when needed.

### Requirements:

Knowledge of heavy equipment mechanics, standard tools, materials and practices to repair and maintain construction equipment; knowledge of hazards and safety precautions associated with the trade.

Skilled in examining and correcting mechanical failure, and in the use and care of tools and equipment.

Ability to analyze mechanical and electrical problems; instruct others in minor repairs; perform welding jobs incidental to mechanical work; and any other related work as needed.

### Pre-Employment Requirements:

Knowledge of mechanical principles and routine repairs on construction equipment; knowledge of standard tools, materials and practices used in making such repairs; knowledge of hazards and safety precautions of the trade.

Ability to understand and perform oral and written instructions, fill out worksheets, perform manual labor involving bending, lifting, carrying, hammering and other similar motions, possibly under adverse weather conditions.

Can be assigned to perform duties in any of the job categories of the Adams County Public Works/ Highway Department.

The normal workweek for full-time employees of the Adams County Highway Department is as follows:

October - April:	Monday through Friday	7:30 a.m. - 4:00 p.m.	(Winter)
April - October:	Monday through Thursday	7:00 a.m. - 5:30 p.m.	(Summer)

The workweek is subject to change at the discretion of the department head.

### Special Requirements:

Licensed to operate a motor vehicle in the State of Nebraska and the ability to obtain a Commercial Driver's License (CDL).

This position is to be considered a Safety Sensitive Position.
